The person completing the questionnaire should include input from the local public health authorities, consult WHO's latest technical guidance and ensure that there is an up-to-date evaluation of the epidemiological situation.

Mitigation checklist for COVID-19

ANTI-CONTACT SAFETY PROTOCOL - Endurance Races of 19-20 June 2021-Montalcino Italy

Biological risk assessment related to the sudden emergency linked to the spread of the SARS-CoV-2 virus (so-called "coronavirus"), the cause of Covid-19 disease

1. Purpose

Given that, in relation to the dangerous situations that have arisen in our country with the spread of COVID-19, with reference to the specific legislative provisions, and in particular to the Prime Ministerial Decree of 22 March 2020, Equestrian Endurance activity is classified with low risk, this document has been prepared in order to assess the biological risk related to the sudden emergency related to the spread of the SARS-CoV-2 virus for Generali endurance ASD in order to define a set of preventive and protective measures aimed at minimizing this risk for the event to be held in Sant'Angelo Scalo-Montalcino Italy 19-20 June 2021

That said, the ASD took steps to adopt all the necessary measures to ensure the contrast and containment of the spread of the new virus during the event, regulating it with this plan to make the event a "Safe place" where riders, the judging commission, the staff, compatibly with the limitations imposed by specific regulatory provisions, can practice the equestrian discipline of Endurance.

In this regard, all necessary precautions are provided which must be adopted for to counter the spread and contagion of COVID-19.

The contents of this document must be brought to the attention and acknowledged by anyone who will be authorized to enter the event indicated above

.2. Introduction

2.1. Generic aspects,

The World Health Organization (WHO) has announced on 11.02.2020 the new name for new coronavirus disease: Covid-19. The name stands for Co (crown); Vi (virus); D ('disease' and 19 (the year the virus was identified).

Coronaviruses are a large family of viruses known to cause diseases ranging from the common cold to more serious diseases such as Middle Eastern Respiratory Syndrome (MERS) and Severe Acute Respiratory Syndrome (SARS). The virus causing the current coronavirus epidemic has been termed "SERIOUS ACUTE RESPIRATORY SYNDROME CORONAVIRUS 2" (SARS-CoV-2). It is a new strain of coronavirus that has never been previously identified in humans before being reported in Wuhan (China) in December 2019.

The disease caused by the new Coronavirus has a name: "COVID-19" (where "CO" stands for corona, "VI" for virus, "D" for disease and "19" indicates the year in which it occurred).


The disease has an "incubation period" or the period of time that passes between the infection and the development of clinical symptoms. It is currently estimated that it varies between 2 and 11 days, up to a maximum of 14 days.

The most common symptoms of a person with COVID-19 are fever, tiredness and dry cough. Some patients may experience soreness and muscle pain, nasal congestion, runny nose, sore throat or diarrhea. These symptoms are generally mild and begin gradually. In severe cases, the infection can cause pneumonia, severe acute respiratory syndrome, kidney failure and even death.

In this regard, some people become infected but do not develop any symptoms. Generally the symptoms are mild, especially in children and young adults, and slow in the beginning. About 1 in 5 people with COVID-19 become seriously ill and have breathing difficulties, requiring hospitalization.

• 2.2. Transmission mode

- Coronaviruses can be transmitted from person to person, usually after close contact with an infected patient, for example between family members or in a healthcare setting.*
- The new Coronavirus responsible for respiratory disease COVID-19 can also be transmitted from person to person through close contact with a probable or confirmed case.*
- The new Coronavirus is a respiratory virus that mainly spreads through close contact with a sick person. The primary way is the breath droplets of infected people, for example through:*

- *saliva, coughing and sneezing*
- *direct personal contacts*
- *hands, for example by touching the mouth, nose or eyes with contaminated (not yet washed) hands*
- *In rare cases, infection can occur through faecal contamination. Normally respiratory diseases are not transmitted with food, which in any case must be handled respecting good hygiene practices and avoiding contact between raw and cooked food. Studies are underway to better understand the modalities of transmission.*
- *2.3. Prevention of contagion No virus is capable of living and reproducing outside of a living being (man or animal), but it can survive some time outside (it is believed that Coronavirus cannot survive more than a few hours outside of the host, but the data are still uncertain since CoVID-19 is a new virus and still not sufficiently known and studied). The true prevention of contagion depends on the probability that people have to come into contact with the viruses emitted by sick subjects or healthy carriers (healthy carriers are those who have been contaminated by the virus without manifesting the symptoms or because it is still early to manifest them or because they will never manifest them by being able to eliminate the virus).*

5. Definition of responsibilities

- **The President, with the help of external and internal consultants, analyzes the critical points associated with the COVID-19 risk**
- **It therefore identifies a method for controlling and managing the risk inherent in the event.**
- **Inform participants of the event about risk management procedures**

The participants in the tender and their assistants, correctly informed by the President, have their own responsibility for compliance with the behaviors defined by current regulations and the rules that the ASD has imposed to manage the COVID -19 risk in order to keep the risk under control.

6. Covid-19 Risk

Risk control is divided into three phases

RISK ASSESSMENTS

RISK MANAGEMENT

COMMUNICATION OF RISK

PHASE 1 Risk assessment

Identification of the specificity of the structure and of the systems exercised in it, for which conditions can be created that connect the actual or potential presence of Covid 19 to the possibility of contracting the infection. This assessment must be carried out individually by each person who will have access to the event by estimating the risk index associated with their personal health status.

PHASE 2 Risk management:

All interventions and procedures aimed at permanently removing or constantly containing the critical issues identified in the risk assessment phase.

PHASE 3 Risk communication:

All actions aimed at informing, training and sensitizing those affected by the potential risk

Risk assessment

The risk index will therefore be specific to each person.

As for Coronavirus, the data available so far allow us to say that this infection can cause different types of infection with which we can associate an IR.

Risk management

Viruses can enter and multiply in all people who come into contact with them, however causing different effects.

Potentially, they can all be at critical risk (3), because everyone could be "temporarily" in a "temporary" risk condition due to some imbalance and weakening of the immune system.

The G factor is therefore individual and depends on various factors.

- Procedures for contrasting SARS-CoV-2 infection
- N. 1 - Correct behavior of the riders inside the place of the event.
- Attendees must strictly comply with the indications given by the C.O. which are considered accepted from the time of registration to be made on www.enduranceonline.it.
- Correct information and awareness about correct behavior is considered the first and most important means of risk management.
- The president will have to provide for appropriate signs, encouraging the dissemination of messages to facilitate the management of flows and awareness of behavior.
- The manager in order to inform and train the athletes and their assistants, the Judging Commission and all the staff, makes information about correct behavior visible in the Secretariat area.
- (All1.). This information indicates
- The obligation to always respect the maintenance of the safety distance.
- Compliance with hand hygiene rules.

- The use of suitable personal protective equipment, starting with a mask that covers the nose and mouth.

The obligation to view this document in order to be properly informed about the procedures for contrasting SARS-CoV-2 infection.

- The need to communicate in advance the arrival time at the place of the event (via phone to n. 3408020896 or 3356230960 at least 30 minutes before arrival)
 - The obligation to register your entry and measure your body temperature
 - The obligation to communicate the names by 13 June by sending the credit and privacy card signed by each person indicated on the card.
 - The obligation to evaluate your IR and act accordingly
 - Race n. 2 companions for each registered rider and the owner of the horse indicated in the passport but the same will not have access to the following areas: vet gate-cool area-rest area-as indicated in the FISE Protocol-Particular Rules Endurance point C.
 - Access restrictions to closed places and the obligation to sanitize surfaces.
- Any information the President deems useful for risk management.

2. Information on "How to wear a mask"

3. Signage "Obligation to keep the safety distance"

5. SARS-CoV-2 anti-contagion handbook

- **Procedure for limiting the risk of gathering inside the place of the event**

- *The president draws up the program of the event as planned as possible so as to dissuade any conditions of aggregations and to regulate the flows of the waiting spaces and in the various areas to encourage compliance with the social distance of at least 1 meter, with the exception of people who on the basis of the current provisions, they are not subject to interpersonal distancing; this last aspect pertains to individual responsibility.*
- *In order to avoid gatherings, the following protocols are put in place.*

~~• Access to the public is prohibited. The event will be held "behind closed doors". Mandatory accreditation request by 13 June 2021 (including representatives from FISE AUTHORITY SPONSOR GUESTS C.O.) as scheduled.~~

- Respect for the safety distance between people not belonging to the same household without device is required by the president (mask)
- Contingent accesses are foreseen on the basis of an entrance program. Athletes, when registering on Enduranceonline accept this protocol and must communicate their arrival at least half an hour before by phoning n. 3408020896 or 3356230960.
- The maximum number of people is calculated based on the capacity of the plants. It is estimated not less than 7 square meters of floor area per person (the Equestrian Centre plant is 31,510 square meters.) Max 4,500 people

- On the basis of an accurate schedule, the president, having assessed the size of the sports facilities of Sant'Angelo Scalo which widely allow the distancing between the athletes, coordinating with the person in charge of the Anti-contagion Protocol, will identify and signal specific routes of entry and exit from the competition field, as well as the cool areas and rest areas that will be named and identified by means of specific signs (bib number).

- As regards the exit of the horses outside the training facilities, control is not the responsibility of the President but is allowed by current legislation while maintaining the spacing that is also done naturally in the specific discipline.

- ***Risk of entry of a positive or positive potential for SARS-CoV-2 infection***

- *In order to check the inputs of positive or potential positive for SARS-CoV-2 infection within the event site, the following procedures are implemented:*

- *Detection of the inlet temperature. In the event that a temperature > 37.5 is detected, access to the person inside the competition field is prohibited.*

- *Self-declaration of the athletes and of the 2 companions, of the Guests and of the Judging Commission, with filling in an individual and parental medical history card at the time of entry that certifies that in the last 14 days the following:*

- *-do not have had a fever or body temperature above 37.5 °*

- *not having had pharyngodynia / sore throat*

- *not to have presented cough and / or difficulty breathing*

- *not having nasal rhinitis / rhinorrhea / obstruction*

- *not having tiredness / muscle pain higher than normal*

- *not having presented diarrhea / vomiting*

- *not showing any alteration of flavors and odors*

- *not being aware of having had contacts with people who have tested positive for Covid 19 (with the exception of medical and nursing staff who have had contacts for work reasons, but in any case with all legal precautions).*

- ***Register of entrances and exits in order to check the incoming flows, to be eventually made available to the Competent Authorities., Which will be carried out by the service staff delegated by the Anti-Contagion Protocol manager.***

Sanitization of environments - Procedure for sanitizing surfaces and environments

Due to the possible survival of the virus in the environment for a long time, the places and areas are subjected to sanitation according to the following procedure:

- *Complete cleaning with water and common detergents once a day.*
- *Sanitization with 1% sodium hypochlorite after cleaning once a day. For surfaces that they can be damaged by sodium hypochlorite, 70% ethanol is used after cleaning with a neutral detergent.*

Ventilation of closed rooms

During cleaning with chemicals, ventilation of the rooms is ensured. All cleaning operations are carried out using PPE

All frequently touched surfaces must be cleaned with particular care, such as walls, doors and windows surfaces, toilet and sanitary surfaces.

- ***Personal hygiene***
- *Hand hygiene. The correct application of preventive measures, such as hand hygiene, can reduce the risk of infection.*
- *The president provides special alcoholic gel dispensers with an alcohol concentration of 60-85%,*
- *Preventive measures such as hand hygiene, respiratory hygiene and social distancing, are advertised inside the place of the event through special information materials displayed.*

Emergency procedure in case of entry into the center of a positive or positive potential for SARS-CoV-2 infection

- ***If the President becomes aware that a positive for SARS-CoV-2 infection has had access to the place of the event, he carries out the following procedure:***
- *Contact the competent authority immediately, if not already informed of the fact, making available all the information in its possession.*

- *Consult the register of entrances in order to determine the date of entry of the positive and the people who came into contact with it.*
- **Provides for the sanitization, as per current legislation, of all environments.**

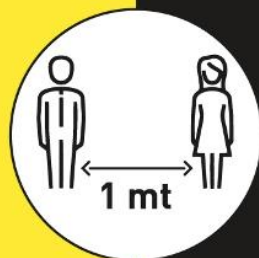

In order to avoid gatherings in the assistance areas, the C.O. and the staff in charge of providing all necessary support to the riders in the race. The staff will have bottles of water and ice available (provided by the C.O.) which will be passed on to the riders upon arrival. It is strictly forbidden to access the assistance areas to unauthorized persons, under penalty of disqualification of the rider in the race, except as provided in point C, particular Endurance rules of the FISE protocol.

C.- SPECIAL ENDURANCE RULES - FISE AGG.TO Protocol August 2020

Base camp

The organizing committee appoints a person responsible for managing access.

All those authorized to access (those already provided for in point 5 b) above, to which up to two assistants can be added to the competitors, in addition to the parents for minors) must undergo the detection of body temperature once a day and if the same should be higher than 37.5 it must be access forbidden.

Paddock area

If there is a paddock area, the same must be delimited and the access allowed for a maximum of two people per horse, which will be indicated by the competitor among those accredited. Paddocks will be identified with the competitor's number and cannot be adjacent, but must have one distance of not less than one and a half meters from each other. The entrance and exit should preferably be separate

Visits area

The preliminary visits / veterinary gate area must be organized with a sufficiently large "heart" area to guarantee the maintenance of an adequate distance between binomial and binomial (currently 1 meter between people and 2 meters with the athletes during the race or training phase The corridors for visits cannot be adjacent, but have a distance of not less than two meters from each other. Access to this area is allowed to one person per horse. The entrance and exit must be separated. Where social distancing cannot be guaranteed, a mask must be worn.

Departures / arrivals area

The departures / arrivals area must be delimited and the access allowed only to the competitors in the race (and to the technician for minors or his companion with the delegation of the responsible technician) with the bib on. In the case of categories under 14, where the figure of the accompanying person is mandatory, access is allowed to competitors and accompanying persons who must be identified by the bib number showing the same number as the competitor to accompany.

Cool Area - Horse Cooling Area

The assistance area must be delimited and sufficiently large to guarantee the maintenance of an adequate distance between binomial and binomial and between tub and tub. In addition to the competitor, access is allowed only to two assistants per horse, in addition to the technician or accompanying person with delegation from the responsible technician in the event of a minor, who must be identified with the same bib number as the competitor to be assisted and must wear the masks as well as remaining the time strictly necessary to carry out the assistance.

. Crew Point

Assistance on the route by the riders crew / assistants is allowed (maximum 2) which must be equipped with their own containers for watering and the cooling of the horses and positioning themselves in such a way as not to create gatherings and contact between horses from different stables. In case there were at the same service point companions / assistants of several pairs belonging to the same team will be prohibited assisting a duo of more than two carers / assistants. Service points must be manned by at least one member of the C.O. who will have to ensure compliance with what above.

The assistance on the route must be organized by the CO, one every 10 km maximum, with 2 tubs for watering the horses and bottles of water placed at "rider height in the saddle" for cooling the horses. These areas must be manned by person appointed by the Organizing Committee and communicated to the President of the Jury with the task of ensuring the presence of water in the mastelloni, of bottles and the respect of the distances by the knights. Therefore, assistance on the route by the Knights' companions / assistants is not allowed except for indifferent necessity (shoeing, accident / illness or withdrawal along the route), and in any case subject to authorization from the President of the Jury and for the time strictly necessary to assist. In the case of a minor competitor, the presence of the technician or accompanying person with delegation is allowed, upon communication to the President of the Jury before the start of the race or during the race and in this case only for reasons arising at the start. The permanence of the technician or accompanying person with delegation is limited to the time strictly necessary to attend the transition of your pupil.

In these cases, the technicians or accompanying persons with delegation must be equipped with personal protective equipment, to be worn if the social distance cannot be guaranteed (1 meter between people and 2 meters with competitors during the race).

This Biosecurity plan is drawn up in accordance with the FEI Post EHV-1 Return to Competition Regulation set out on 9 April and extended from 31 May until 31 December in order to allow the return to competitions and at the same time protect horses and equestrian sports from the consequences of infectious diseases transmitted before during and after FEI events. Assessment of the biological risk related to the sudden emergency linked to the spread of EHV-1

Given that Italy is one of the countries indicated by the FEI among those that need measures that allow the return to competitions in total safety in relation to the dangerous situations that have arisen in recent weeks with the spread of the EHV-1 HERPES virus, this document was drawn up in order to define a set of preventive and protective measures aimed at minimizing the risk of contagion for the event to be held in Montalcino on 19 and 20 June 2021

That said, the ASD has taken steps to take all the necessary measures to ensure the contrast and containment of the spread of the new virus, regulating it with this plan to make the event a "safe place" for the participating horses.

In this regard, all the necessary precautions are provided that must be adopted to counter the spread and contagion of the EHV-1 virus.

The contents of this document must be brought to the attention and acknowledged by anyone authorized to enter the event indicated above.

2. Introduction

2.1. Generic aspects,

The EHV virus occurs in 4 different types that affect 4 different systems of the horse, in this case the most lethal and contagious is that of type 1, in jargon EHV-1.

2.2 Symptoms of EHV-1

The most common form is type 1 which affects the respiratory system of the horse. In the most common form, it presents respiratory diseases with variable symptoms that include fever, nasal discharge, swollen lymph nodes, cough, loss of appetite and significant physiological drops, which are quite common symptoms and can be misleading and alarming those who observe the horse. In more serious cases, the Herpes Virus can also have repercussions from a neurological point of view, leading to paralysis and death.

2.2. Method of transmission

The EHV-1 virus, also known as Rhinopneumonia, has a very high viral load and is very easily transmitted by air, by direct contact between horses and also through surfaces that have come into contact with the viral components. For this reason, both sporting events and daily life in individual stables can be dangerous if the necessary precautions are not taken. It is possible, however, that horses spread the Equine Herpes Virus even without showing clinical signs (the so-called asymptomatic carriers), transmitting it only in certain environmental conditions such as stress, transport and competitions.

2.3 Diagnosis

Observing symptoms, especially at the respiratory level, cannot always lead to a correct diagnosis of rhinopneumonia, so in these cases it is categorically recommended to contact a veterinarian who can evaluate all the hypotheses. Using a classic swab or serological tests, it is possible to establish whether a respiratory infection is associated with EHV-1, by taking two blood samples 10 days apart on which the antibody titration is carried out.

2.4 Treatment and convalescence

The recommended treatment starts, first of all, with the isolation and quarantine of the person infected with the herpes virus. Unfortunately, being a virus, there is no specific and targeted cure. Treatment of equine herpes virus respiratory infections usually consists of supportive therapy, as human anti-herpes drugs are not effective in horses. Antipyretics and antitussives are administered, but also antibiotics to prevent or fight secondary bacterial infections, and to shorten the recovery period. However, with the help of a veterinary expert, a cure can be identified to treat the symptoms resulting from EHV-1 such as general weakness, loss of appetite and apathy. It is possible to preserve his respiratory health in a preventive manner through alternative methods recommended by us such as purified hay. However, in summary, the only remedies are prevention and the vaccine.

2.5 Prevention

- *In order to reduce the incidence of EHV-1 infection and to minimize its spread, it is necessary to sanitize the living environments of horses combined with particularly thorough hygiene through disinfectants.*
- *The isolation of the horse and tools is mandatory in case of contact with the virus.*
- *The prevention of contagion depends on the probability that horses have of coming into contact with the virus emitted by a sick person or a healthy carrier (a healthy carrier is defined as the person who, even if contaminated, does not show symptoms or because it is too early to manifest them or because will never manifest being able to eliminate the virus autonomously).*

Procedures for contrasting EHV-1 infection

No. 1 - Correct behavior of the riders within the place of the event.

Visitors must strictly comply with the instructions given by the O.C. which are considered accepted from the moment of registration to be made on www.enduranceonline.it.

- Correct information and awareness of correct behavior is considered the first and most important means of managing risk.
- The President will have to provide suitable signs, encouraging the dissemination of messages and raising awareness of behavior.
- In order to inform and train the athletes and their assistants, the Judging Commission and all the staff, the person in charge makes information on the correct behavior to prevent the spread of the EHV-1 virus visible in the Secretariat area
- *The obligation to wash your hands with gel at the entrance and exit of the stables*
- *The obligation not to water horses on common containers but to use only their own containers*
- *The obligation to view this document in order to be properly informed about the procedures for fighting the infection*
- *The obligation to record the horse's temperature at least in the 10 days prior to the event in the form prepared by the FEI.*
- *The obligation to measure and record the temperature twice a day in the appropriate cards prepared by the O.C. out of the box*
- *The obligation to observe the entry and exit from the stables as indicated by the O.C.*
- *The obligation to carefully observe the distance from other horses of at least 5 m.*
- *The obligation to saddle the horse inside the assigned box and to use only personal harness*
- *The obligation to send the box form by 18 April with the indication of the date and time of arrival*

The C.O. will arrange for the immediate disinfection of the box used.

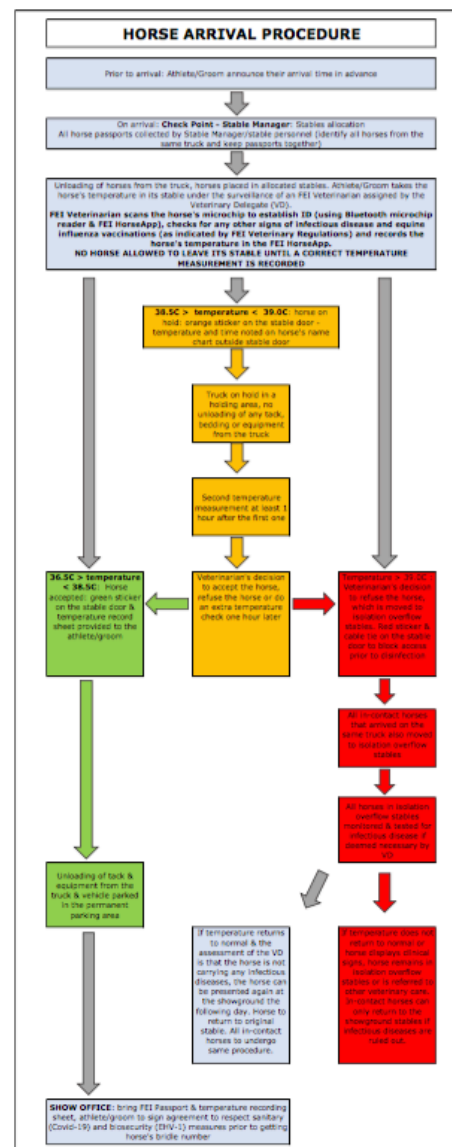

IV. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount

and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

1. Injury Surveillance

FEI Veterinary Regulations, **Chapter VIII:**

Horses participating in FEI Events are subject to injury surveillance protocols; and in the event of fatality, a post mortem examination.

2. Transport Of Horses

Horses must be fit to travel and be transported in suitable vehicles f. Any government requirements for disease testing and control must be requested well in advance, to ensure that the horse is in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have the responsibility to

comply with national legislation in both their country of origin and the host nation of the Event. Where necessary athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005 concerning the protection of animals during transport within the Member States of the EU.

3. Venue Arrival Information & Fitness To Compete

6.1 Passports. FEI General Regulations

All Horses competing at FEI Events must be registered with the FEI.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

NB: Horses in CIMs, in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (GRs. 137.2).

Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be **subject to Sanctions in accordance with Annex VI of the FEI Veterinary Regulations** and may not be allowed to compete.

NB: for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

6.2 Vaccinations - Equine Influenza

FEI Veterinary Regulations Article 1003

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the relevant territory.

6.3 Examination On Arrival

FEI Veterinary Regulations Article 1031

On arrival at an Event venue all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status, concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

6.4 Horse Inspections

FEI Veterinary Regulations Articles 1034-1042

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the

Inspection Panel will not be permitted to compete.

6.5 Limb Sensitivity Examination

FEI Veterinary Regulations Articles 1048-1053

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event. For Jumping that includes, but is not limited to, between rounds and before the Jump Off. For Endurance that includes, but is not limited to, pre-ride, during the ride and after the ride. Horses may be examined once or on multiple occasions during the Period of an Event.

Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

7 Equine Anti-Doping And Controlled Medication Programme (EADCMP).

FEI Veterinary Regulations, Chapter VII

7.1 Sampling.

FEI Veterinary Regulations, Chapter VII

All horses competing at FEI Events may be subject to sampling for the presence of FEI Equine Prohibited Substances in accordance with the FEI Equine Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

7.2 Elective Testing.

FEI Veterinary Regulations Articles 1058

Elective Testing may be carried out prior to an Event to check for the presence of Prohibited Substances. Please refer to <http://inside.fei.org/fei/your-role/veterinarians> for information and details.

7.3 Hyposensitivity Control System Examination **FEI Veterinary Regulations, Annex VIII**

All horses competing in FEI Endurance events are subject to Hyposensitivity Control System Examination. Horses may be examined once or on multiple occasions during the Period of the Event and may be selected randomly and/or target tested by the Ground Jury and/or Veterinary Commission.

All horses selected to be tested must submit promptly to the examination. A refusal by the PR or his/her representative to submit a horse for examination will lead to disqualification and a yellow warning card. Withdrawal of the horse is not allowed once the PR or support personnel has been notified that the examination is to take place.

XIV. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEIs' Anti-doping Rules for Human Athletes (ADRHA).

XV. ADDITIONAL INFORMATION

1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic ("Policy") <https://inside.fei.org/fei/covid-19/return-to-play/policy-tools> is mandatory and applies for any FEI Event taking place **as of 1 July 2020**. The Policy has been developed based on currently accepted best practices by the WHO and US Center for Disease Control (CDC) and will be continually reviewed and updated as more information becomes available. It is not intended to replace the applicable guidance and policies from domestic government and health authorities, but to supplement their recommendations with sport specific considerations.

The OC shall submit the risk assessment and mitigation plan (including name and contact details of the person in charge) to the FEI as an annex to the Event Schedule, **at the latest ten (10) working days before the event's deadline for Definite Entries**.

Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy **will be removed from the FEI calendar** in accordance with Article 112.3 of the FEI General Regulations.

ASSUMPTION OF RISK / WAIVER OF LIABILITY

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,
3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
4. The Participants, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.

2. Insurances And National Requirements

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate.

2.1 ATHLETES, OWNERS AND SUPPORT PERSONNEL

2.1.1 Personal Accident and Health Insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending at/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

2.1.2 Personal Property Insurance

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

2.1.3 Press Equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

2.2 ATHLETES AND OWNERS

2.2.1 Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

2.2.2 Additional Liability Information

To be valid, all Protests and Appeals must be made in writing and accompanied by a deposit of CHF150. – or equivalent.

5. Modifications Of Schedule

In exceptional circumstances, together with the approval of Chefs d'Equipe and Ground Jury the OC reserves the right to modify the schedule in order to clarify any matter or matters arising from an omission or due to unforeseen circumstances.

Unforeseen circumstances do not include situations arising as a result of the OC altering the approved Schedule without FEI's authorisation. Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the FEI Secretary General by the Foreign Judge.

With an aim to further ensure the welfare of equine and human athletes at International Endurance Events, the safety of all participants and the implementation and respect of common principles of behaviour, fairness, and sportsmanship, the FEI has created this FEI Endurance Organiser's Protocol (hereinafter the "Endurance Protocol") to guarantee the correct and full application of the applicable FEI Rules and Regulations in your Events, in particular but not limited to, the FEI General Regulations, the FEI Endurance Rules, the FEI Veterinary Regulations, the FEI Anti-Doping Rules for Human Athletes and the FEI Equine Anti-Doping and Controlled Medication Regulations.

In order for the FEI to approve the competition schedules the Endurance Protocol **must** be signed by the Organiser and the National Federation, listing the Event(s). By signing the Endurance Protocol both aforementioned parties agree to comply with all applicable FEI Rules and Regulations, and in particular (but not limited to), with the following requirements:

1. Full cooperation must be given to the FEI Officials to ensure that they can perform their tasks according to the FEI Endurance Rules, in particular:
 - Ground Jury Art. – Art. 853
 - Technical Delegate – Art. 852
 - Veterinary Commission – Art. 854
 - Chief Steward Art. – Art. 855
2. Full cooperation must be given to the FEI Independent Governance Advisors (IGAs) to ensure that they can perform their tasks according to the FEI Endurance Rules Art. 856
3. The welfare of the horse must be a first priority and you must allow the FEI Officials to take all necessary measures to safeguard it, as per the FEI Endurance Rules, including but not limited to:
 - Loops of the course must not be specially designed and/or constructed to encourage high speeds - Art. 818
 - Allowing for the reduction of the pulse criteria - Art. 816.9.2. The pulse criteria may be reduced during the ride if, in the opinion of the President of the Veterinary Commission in consultation with the Foreign Veterinary Delegate, the President of the Ground Jury and the Technical Delegate they believe there is a danger to the safety of the Horses.
 - The Veterinary Commission has absolute control on all matters concerning horse welfare – Annex 5, Art.1.
 - The Technical Delegate or the Ground Jury together with the Veterinary Commission can decide to modify the length of timed holds according to extreme weather conditions or other exceptional circumstances.... - Art. 816.9.3.

4. The safety of the athletes, FEI Officials and public must be safeguarded at all times and FEI Officials must be allowed to take all necessary measures to ensure safety, as per the FEI Endurance Rules/FEI GRs:
- The field of play - Art. 813
 - Number of crew members allowed - Art. 813.2.2
 - Horses must remain capable of being clearly observed at all times - Art. 813.5
 - Permitted Assistance during Event or on Course - Art. 822.4
 - Prohibited Assistance - Art. 822.5
 - Postponement and/or cancellation of an Event - FEI GRs 109.12
5. The FEI Officials' Code of Conduct must be adhered to including the obligations and restrictions pertaining to the "Endurance Official's Per Diems".

Any breach of the FEI Rules and Regulations will be prosecuted according to the FEI Legal System (Chapter VIII of the FEI General Regulations).
