(drawn up on the basis of the provisions currently in force subject to updating)

Remember that the first protective measure, on which all the others depend, is the SENSE OF RESPONSIBILITY OF EACH ONE. Never as in this case, protection is only effective if implemented by

PREVENTION AND PROTECTION MEASURES

The prevention and protection measures are aimed at managing the risk of contagion within the event.

They must be adopted bearing in mind that the prevention and protection measures are not to be understood as alternatives to each other, but as minimum equipment in order to prevent contagion in relation to the current epidemiological situation in progress.

The main contagion prevention measures are:

- a) Interpersonal distancing
- b) Hygiene and personal protective equipment:
 - Hand hygiene (sanitizing gel dispensers are placed in all common areas).
 - During the stay in the open spaces inside the structure, the mask must be worn, according to the regulations in force at the time of drafting this protocol, if it is not possible to respect the interpersonal distance of 1 meter between people and 3 meters with the athletes in training or competition phase, and must not be worn by athletes when they are training or competing.
 - Physical contact is forbidden (eg handshake, hugs, etc.).
 - A mask must be worn in closed rooms.

AUTHORIZED ACCESS:

- the competitor
- the instructor
- 2 assistants per competitor - the van driver
- parents ONLY FOR MINORS
- the staff and / collaborators of the Organizing Committee dedicated to organizing the event
- any veterinarians, if requested by the competitors, the time strictly necessary for the visit, treatment or therapy of the horse
- any medical personnel if requested by the competitor

AUTHORIZED ACCESSES (IF NUMBERS ALLOW IT)

- the owner of the horse (only if requested in advance and the name coincides with that on the passport)
- the legal representative of the home center or his / her delegate (with written proxy) - the Federal President and the Federal Councilors
- the Regional President and the Regional Councilors
- any figures specifically delegated by the Federation

At the time of registration or at a later stage, but in any case before the start of the event, the competitor or their center or the instructor must send the names of the people who intend to be accredited to the Organizing Committee.

At the entrance to the event, a control point will be set up which will verify the correspondence between the names provided and the identity documents, record the body temperature and withdraw the form attached to this protocol.

In order to speed up the access procedure and speed up the control phase, everyone (riders and accompanying persons) are invited to print the attached form.

For transport, the electronic pink sheet is mandatory to be delivered at the entrance printed or sent by email. Mask compulsory and the use of gloves is also recommended.

Maximum 1 person inside at a time.

Mask compulsory and the use of gloves is also recommended.

PADDOCK AREA

Paddocks cannot be adjacent to each other, they must be marked with the competitor's bib number; access is allowed to a maximum of 2 people at a time

DEPARTURE / ARRIVAL AREA

Access allowed only to competitors in the race (and to the technician for minors or his accompanying person with delegation of the responsible technician) wearing the bib. The starts will be staggered, one starter every 3 minutes minimum, even in speed races.

ASSISTANCE

Access to the assistance area is allowed, in addition to the competitor, only to two assistants per horse, in addition to the technician or accompanying person with the delegation of the responsible technician in the case of a minor, who must be identified with the same bib number as the competitor to be assisted and wear the masks and stay the time strictly necessary to

carry out the assistance. The assistance on the route is organized by the CO, one every 10 km maximum, with 2 tubs for the watering of the horses and water bottles placed at "rider height" for the cooling of the horses.

Organizing Committee and communicated to the President of the Jury with the task of guaranteeing the presence of water in tubs, bottles and respect for the distances by the riders. Therefore, assistance on the route by the riders / assistants of the Riders is not allowed. if not for indifferent necessity (shoeing, accident / illness or withdrawal along the route), and in any case subject to the authorization of the President of the Jury and the time strictly necessary to carry out the assistance. In the case of a minor competitor, the presence of the technician or companion is allowed by proxy, subject to communication to the President of the Jury before the start of the race or during the race and in this case only for motivations incurred upon departure.

The stay of the technician or accompanying person with a proxy is limited to the time strictly necessary to assist in the passage of their pupil. In these cases, the technicians or assistants with delegation must be equipped with personal protective equipment, to be worn if it is not possible to guarantee the social distance (1 meter between people and 2 meters with the competitors during the race).

INFORMATION ON PERSONAL DATA PROCESSING

Type of personal data processed and of interested parties Within the limits of the purposes and methods defined in this information note, the following are processed:

- a) data relating to the body temperature of the person concerned, detected or certified by the same to an extent not exceeding 37.5 ° C;
- b) data relating to non-submission to quarantine measures or fiduciary isolation with health surveillance. The personal data being processed refer to: the staff of the Club.

With respect to these interested parties, this information integrates quella già fornita for the processing of personal data functional to the establishment and execution of the employment relationship; to members, suppliers, transporters, contractors, visitors and other third parties authorized to access the structures of the Organizing Committee TORGNON ENDURANCE or other places related to the latter.

Purpose and legal basis of the processing Personal data will be processed exclusively for the purpose of preventing the contagion from COVID-19, in execution of the adopted anti-contagion security protocol.

The legal basis of the processing is, therefore, to be found in the implementation of this Protocol. Nature of the provision of personal data The provision of data is necessary to access the structures of the Organizing Committee TORGNON ENDURANCE or to other places in any case referable to the latter. Any refusal to give them prevents you from allowing entry.

Methods, scope and duration of the processing The processing is carried out by the Head of the Club, in his capacity as Data Processor. With reference to the measurement of body temperature, the Club does not make any data recording.

The identification of the interested party and the recording of the exceeding of the temperature threshold could take place only if it was necessary to document the reasons that prevented access. In this case, the interested party will be informed of the circumstance. Personal data will not be disseminated or communicated to third parties, except on the basis of specific regulatory provisions (e.g. in the event of a request by the Health Authority for the reconstruction of the supply chain of any close contacts of a positive worker to COVID-19).

The data will be processed for the time strictly necessary to pursue the aforementioned purpose of preventing the contagion from COVID-19 and stored at the Club no later than the term of the state of emergency, currently set at 31 July 2020 of the Resolution of the Council of Ministers 31. January 2020.

Rights of interested parties At any time, interested parties have the right to access their personal data, to request their correction, updating and related cancellation. It is also

possible to oppose the processing and request its limitation. These requests may be addressed directly to the (TORGNON ENDURANCE) that the processing has been carried out in violation of the legislation on the protection of personal data, the right to lodge a complaint with the Guarantor Authority for the protection of personal data, Piazza Venezia, 11 - 00187 - Rome is recognized.

Guidance for the use of the WHO Risk Assessment tools in the context of COVID-19 - FEI version

Guidance for FEI Event organisers ("OCs") during the current outbreak of COVID-19

In view of the current outbreak of COVID-19, this disease-specific and event-specific risk assessment and mitigation checklist has been developed by WHO for use by host countries and event organizers, to assess the specific risk of COVID-19.

The FEI has slightly adapted the wording in the document, mainly by replacing the initial term "mass gathering sporting event" by "FEI Event".

Under the FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic, which applies to all FEI Events taking place after 1 July 2020, all OCs of FEI Events must carry out a risk assessment of their Event in terms of Covid-19 transmission, using the present document.

The following risk assessment and mitigation checklist should be used in conjunction with the "WHO Mass Gathering Sports Addendum Guidelines" - OCs should consider the term "mass gathering" in it as synonym of "FEI Event" in this context.

In order to accurately provide answers the following risk assessment and mitigation checklist, OCs must be knowledgeable on the current COVID-19 outbreak. OCs should reference the daily global COVID-19 situation reports provided by WHO as well as the national COVID-19 situation reports, if available.

The tool must be completed in this Excel spreadsheet (see following tabs), as the scores are automatically calculated there. Once the tool is completed, the scores received in the Excel spreadsheet for both sections will appear in the decision matrix found on the final tab ("Overall risk scores") for the Event's overall risk score to be determined.

It must be ensured that this risk assessment is conducted with input from local public health authorities and that the necessary personnel with expertise in mass gatherings, risk assessment, epidemiology, and infectious disease control measures are included from the initial stages of planning.

For the final determination, factors under consideration include:

- the current stage of the COVID-19 outbreak and known transmission dynamics
- the geographical distribution and number of participants, and their individual risk profile
- the risk assessment tool
- the mitigation measures that are currently in place or feasible and any discipline-specific guidance issued by the FEI.

It is important to remember that while mitigation measures can reduce the risk of COVID-19 infections, they cannot completely eliminate the threat. It is WHO's view that all countries with community transmission should seriously consider postponing or reducing sport events that bring people together and have the potential to amplify disease, and support the recommended best practice of physical distancing. Any decision will be supported through the use of WHO tools, in particular this risk assessment tool.

If movement restrictions and further national measures have been established in the country, the risk assessment does not apply.

However, when the process of re-opening/conducting mass gatherings is being considered post movement restrictions, it will be key to ensure any decisions are based on a risk assessment, such as the WHO Mass gatherings COVID-19 risk assessment.

Risk assessment for COVID-19

The questions below will enable OCs to review the additional considerations specific to sports, and thus inform their risk assessment of COVID-19 associated with their Event. This will help OCs understand and manage any additional risk from COVID-19.

The risk assessment should be reviewed and reassessed regularly during the planning phase and updated immediately prior to the transition to the operational phase, especially in light of the rapidly evolving nature of the outbreak. Reference should be made to the latest technical guidance and situation reports on the WHO website.

The risk assessment for COVID-19 associated with the Event must be coordinated and integrated with the host country's national risk assessment for COVID-19. The person completing the questionnaire should include input from the local public health authorities, consult WHO's latest technical guidance and ensure that there is an up-to-date evaluation of the epidemiological situation.

Mitigation checklist for COVID-19

Mitigation measures assess the current effort and planning to reduce the risk of spread of COVID-19 disease for the event. As mitigation measures can reduce the overall risk of the sporting event contributing to the spread of COVID-19, they should be taken into account after the risk assessment has occurred to gain a clearer understanding of the overall risk of transmission and further spread of COVID-19, should the event be held. Together with the risk assessment score, the mitigation measure will contribute to the decision matrix and influence the assessment of the overall risk of transmission and further spread of COVID-19 in relation to the event.

IV. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

- 2) an ATA form, especially for extra European Countries or in the case the horse will pass through not EU Countries (crossing not communitarian nations) (for further information see: <http://www.atacarnet.com/>);
- 3) official veterinary health certificates on the International Form issued from the official veterinary health authorities of the Country of origin: a) for horses from European Countries see Annex II or Annex III of Council Directive 2009/156, please remember that these Annexes still in force only 10 days AND the addition of the horses in the TRACES system (Commission Decision 2004/292/EC); b) for Re-entry of registered horses after temporary export to approved non-EU countries from European Countries see commission implementing regulation (EU) 2018/659 and respective subsequent amendment (e.g. commission implementing regulation (EU) 2018/1301) c) for horses from NOT European Countries see commission implementing regulation (EU) 2018/659 and respective subsequent amendment (e.g. commission implementing regulation (EU) 2018/1301)

3. National Requirements

4. Injury Surveillance

FEI Veterinary Regulations, **Chapter VIII**:

Horses participating in FEI Events are subject to injury surveillance protocols; and in the event of fatality, a post mortem examination.

5. Transport Of Horses

Horses must be fit to travel and be transported in suitable vehicles f. Any government requirements for disease testing and control must be requested well in advance, to ensure that the horse is in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have the responsibility to comply with national legislation in both their country of origin and the host nation of the Event. Where necessary athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005 concerning the protection of animals during transport within the Member States of the EU.

6. Venue Arrival Information & Fitness To Compete

6.1 Passports. FEI General Regulations

Article 137

For all Horses on FEI Passports/FEI Recognition Cards issues, please address to your National Federation

All Horses competing at FEI Events must be registered with the FEI.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

NB: Horses in CIMs, in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (GRs. 137.2).

Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be **subject to Sanctions in accordance with Annex VI of the FEI Veterinary Regulations** and may not be allowed to compete.

NB: for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

6.2 Vaccinations - Equine Influenza

FEI Veterinary Regulations Article 1003

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the relevant territory.

6.3 Examination On Arrival

FEI Veterinary Regulations Article 1031

On arrival at an Event venue all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status, concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

6.4 Horse Inspections

FEI Veterinary Regulations Articles 1034-1042

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

6.5 Limb Sensitivity Examination

FEI Veterinary Regulations Articles 1048-1053

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event. For Jumping that includes, but is not limited to, between rounds and before the Jump Off. For Endurance that includes, but is not limited to, pre-ride, during the ride and after the ride. Horses may be examined once or on multiple occasions during the Period of an Event.

Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

7 Equine Anti-Doping And Controlled Medication Programme

(EADCMP).**FEI Veterinary Regulations, Chapter VII****7.1 Sampling.****FEI Veterinary Regulations, Chapter VII**

All horses competing at FEI Events may be subject to sampling for the presence of FEI Equine Prohibited Substances in accordance with the FEI Equine Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

7.2 Elective Testing.**FEI Veterinary Regulations Articles 1058**

Elective Testing may be carried out prior to an Event to check for the presence of Prohibited Substances. Please refer to <http://inside.fei.org/fei/your-role/veterinarians> for information and details.

7.3 Hyposensitivity Control System Examination**FEI Veterinary Regulations, Annex VIII**

All horses competing in FEI Endurance events are subject to Hyposensitivity Control System Examination. Horses may be examined once or on multiple occasions during the Period of the Event and may be selected randomly and/or target tested by the Ground Jury and/or Veterinary Commission.

All horses selected to be tested must submit promptly to the examination. A refusal by the PR or his/her representative to submit a horse for examination will lead to disqualification and a yellow warning card. Withdrawal of the horse is not allowed once the PR or support personnel has been notified that the examination is to take place.

XIV. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEIs' Anti-doping Rules for Human Athletes (ADRHA).

XV. ADDITIONAL INFORMATION

1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic ("Policy") <https://inside.fei.org/fei/covid-19/return-to-play/policy-tools> is mandatory and applies for any FEI Event taking place **as of 1 July 2020**. The Policy has been developed based on currently accepted best practices by the WHO and US Center for Disease Control (CDC) and will be continually reviewed and updated as more information becomes available. It is not intended to replace the applicable guidance and policies from domestic government and health authorities, but to supplement their recommendations with sport specific considerations.

The OC shall submit the risk assessment and mitigation plan (including name and contact details of the person in charge) to the FEI as an annex to the Event Schedule, **at the latest ten (10) working days before the event's deadline for Definite Entries.**

Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy **will be removed from the FEI calendar** in accordance with Article 112.3 of the FEI General Regulations.

ASSUMPTION OF RISK / WAIVER OF LIABILITY

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,
3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
4. The Participants, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.

2. Insurances And National Requirements

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate.

2.1 ATHLETES, OWNERS AND SUPPORT PERSONNEL

2.1.1 Personal Accident and Health Insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending at/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

2.1.2 Personal Property Insurance

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

2.1.3 Press Equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

2.2 ATHLETES AND OWNERS

2.2.1 Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

2.2.2 Additional Liability Information

The event will respect the covid - 19 health protocol provided by the Ministry of Health and the FISE for the contrast and containment of the virus covid 19.

WE ARE NOT RESPONSIBLE FOR YOUR SAFETY – IT'S YOUR OWN RESPONSIBILITY AND IF YOU DON'T RESPECT THE GENERAL HYGIENIC RULES AND OUR SPECIAL HYGIENIC RULES THE RIDER WILL BE ELIMINATED AND HAS TO LEAVE IMMEDIATELY THE SHOWGROUND (including his crew member)

2.2.3 Horse Insurance

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

[FEI Permitted Treating Veterinarians \(PTVs\) \(Art 1005\) are to have adequate professional indemnity insurance.](#)

3. Protests / Appeals

To be valid, all Protests and Appeals must be made in writing and accompanied by a deposit of CHF150. – or equivalent.

4. Disputes

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

5. Modifications Of Schedule

In exceptional circumstances, together with the approval of Chefs d'Equipe and Ground Jury the OC reserves the right to modify the schedule in order to clarify any matter or matters arising from an omission or due to unforeseen circumstances.

Unforeseen circumstances do not include situations arising as a results of the OC altering the approved Schedule without FEI's authorisation. Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the FEI Secretary General by the Foreign Judge.

With an aim to further ensure the welfare of equine and human athletes at International Endurance Events, the safety of all participants and the implementation and respect of common principles of behaviour, fairness, and sportsmanship, the FEI has created this FEI Endurance Organiser's Protocol (hereinafter the "Endurance Protocol") to guarantee the correct and full application of the applicable FEI Rules and Regulations in your Events, in particular but not limited to, the FEI General Regulations, the FEI Endurance Rules, the FEI Veterinary Regulations, the FEI Anti-Doping Rules for Human Athletes and the FEI Equine Anti-Doping and Controlled Medication Regulations.

In order for the FEI to approve the competition schedules the Endurance Protocol **must** be signed by the Organiser and the National Federation, listing the Event(s). By signing the Endurance Protocol both aforementioned parties agree to comply with all applicable FEI Rules and Regulations, and in particular (but not limited to), with the following requirements:

1. Full cooperation must be given to the FEI Officials to ensure that they can perform their tasks according to the FEI Endurance Rules, in particular:
 - Ground Jury Art. – Art. 853
 - Technical Delegate – Art. 852
 - Veterinary Commission – Art. 854
 - Chief Steward Art. – Art. 855
2. Full cooperation must be given to the FEI Independent Governance Advisors (IGAs) to ensure that they can perform their tasks according to the FEI Endurance Rules Art. 856
3. The welfare of the horse must be a first priority and you must allow the FEI Officials to take all necessary measures to safeguard it, as per the FEI Endurance Rules, including but not limited to:
 - Loops of the course must not be specially designed and/or constructed to encourage high speeds - Art. 818
 - Allowing for the reduction of the pulse criteria - Art. 816.9.2. The pulse criteria may be reduced during the ride if, in the opinion of the President of the Veterinary Commission in consultation with the Foreign Veterinary Delegate, the President of the Ground Jury and the Technical Delegate they believe there is a danger to the safety of the Horses.
 - The Veterinary Commission has absolute control on all matters concerning horse welfare – Annex 5, Art.1.
 - The Technical Delegate or the Ground Jury together with the Veterinary Commission can decide to modify the length of timed holds according to extreme weather conditions or other exceptional circumstances.... - Art. 816.9.3.

4. The safety of the athletes, FEI Officials and public must be safeguarded at all times and FEI Officials must be allowed to take all necessary measures to ensure safety, as per the FEI Endurance Rules/FEI GRs:
- The field of play - Art. 813
 - Number of crew members allowed - Art. 813.2.2
 - Horses must remain capable of being clearly observed at all times - Art. 813.5
 - Permitted Assistance during Event or on Course - Art. 822.4
 - Prohibited Assistance - Art. 822.5
 - Postponement and/or cancellation of an Event - FEI GRs 109.12
5. The FEI Officials' Code of Conduct must be adhered to including the obligations and restrictions pertaining to the "Endurance Official's Per Diems".

Any breach of the FEI Rules and Regulations will be prosecuted according to the FEI Legal System (Chapter VIII of the FEI General Regulations).
