ANTI-CONTACT SAFETY PROTOCOL - Endurance Races of 26-27 AUGUST GROSSETO ITALY

Integration to the DVR-RISK ASSESSMENT DOCUMENT pursuant to art. 17, 28 and 29 of Legislative Decree 9 April 2008, N.81 and as amended

Biological risk assessment related to the sudden emergency linked to the spread of the SARS-CoV-2 virus (so-called "coronavirus"), the cause of Covid-19 disease

1. Purpose

Given that, in relation to the dangerous situations that have arisen in our country with the spread of COVID-19, with reference to the specific legislative provisions, and in particular to the Prime Ministerial Decree of 22 March 2020, Equestrian Endurance activity is classified with low risk, this document has been prepared in order to assess the biological risk related to the sudden emergency related to the spread of the SARS-CoV-2 virus for Generali endurance ASD in order to define a set of preventive and protective measures aimed at minimizing this risk for the event to be held in GROSSETO 26-27 AUGUST 2022

That said, the ASD took steps to adopt all the necessary measures to ensure the contrast and containment of the spread of the new virus during the event, regulating it with this plan to make the event a "Safe place" where riders, the judging commission, the staff, compatibly with the limitations imposed by specific regulatory provisions, can practice the equestrian discipline of Endurance.

In this regard, all necessary precautions are provided which must be adopted for to counter the spread and contagion of COVID-19.

The contents of this document must be brought to the attention and acknowledged by anyone who will be authorized to enter the event indicated above

.2. Introduction

2.1. Generic aspects,

The World Health Organization (WHO) has announced on 11.02.2020 the new name for new coronavirus disease: Covid-19. The name stands for Co (crown); Vi (virus); D ('disease' and 19 (the year the virus was identified).

Coronaviruses are a large family of viruses known to cause diseases ranging from the common cold to more serious diseases such as Middle Eastern Respiratory Syndrome (MERS) and Severe Acute Respiratory Syndrome (SARS). The virus causing the current coronavirus epidemic has been termed "SERIOUS ACUTE RESPIRATORY SYNDROME CORONAVIRUS 2" (SARS-CoV-2). It is a new strain of coronavirus that has never been previously identified in humans before being reported in Wuhan (China) in December 2019.

The disease caused by the new Coronavirus has a name: "COVID-19" (where "CO" stands for corona, "VI" for virus, "D" for disease and "19" indicates the year in which it occurred).

The disease has an "incubation period" or the period of time that passes between the infection and the development of clinical symptoms. It is currently estimated that it varies between 2 and 11 days, up to a maximum of 14 days.

The most common symptoms of a person with COVID-19 are fever, tiredness and dry cough. Some patients may experience soreness and muscle pain, nasal congestion, runny nose, sore throat or diarrhea. These symptoms are generally mild and begin gradually. In severe cases, the infection can cause pneumonia, severe acute respiratory syndrome, kidney failure and even death.

In this regard, some people become infected but do not develop any symptoms. Generally the symptoms are mild, especially in children and young adults, and slow in the beginning. About 1 in 5 people with COVID-19 become seriously ill and have breathing difficulties, requiring hospitalization.

• 2.2. Transmission mode

- Coronaviruses can be transmitted from person to person, usually after close contact with an infected patient, for example between family members or in a healthcare setting.*
- The new Coronavirus responsible for respiratory disease COVID-19 can also be transmitted from person to person through close contact with a probable or confirmed case.*
- The new Coronavirus is a respiratory virus that mainly spreads through close contact with a sick person. The primary way is the breath droplets of infected people, for example through:*

- *saliva, coughing and sneezing*
- *direct personal contacts*
- *hands, for example by touching the mouth, nose or eyes with contaminated (not yet washed) hands*
- *In rare cases, infection can occur through faecal contamination. Normally respiratory diseases are not transmitted with food, which in any case must be handled respecting good hygiene practices and avoiding contact between raw and cooked food. Studies are underway to better understand the modalities of transmission.*
- • *2.3. Prevention of contagion No virus is capable of living and reproducing outside of a living being (man or animal), but it can survive some time outside (it is believed that Coronavirus cannot survive more than a few hours outside of the host, but the data are still uncertain since CoVID-19 is a new virus and still not sufficiently known and studied). The true prevention of contagion depends on the probability that people have to come into contact with the viruses emitted by sick subjects or healthy carriers (healthy carriers are those who have been contaminated by the virus without manifesting the symptoms or because it is still early to manifest them or because they will never manifest them by being able to eliminate the virus).*

5. Definition of responsibilities

- *The President, with the help of external and internal consultants, analyzes the critical points associated with the COVID-19 risk*
- *It therefore identifies a method for controlling and managing the risk inherent in the event.*
- *Inform participants of the event about risk management procedures*

The participants in the tender and their assistants, correctly informed by the President, have their own responsibility for compliance with the behaviors defined by current regulations and the rules that the ASD has imposed to manage the COVID -19 risk in order to keep the risk under control.

6. Covid-19 Risk

Risk control is divided into three phases

RISK ASSESSMENTS

RISK MANAGEMENT

COMMUNICATION OF RISK

PHASE 1 Risk assessment

Identification of the specificity of the structure and of the systems exercised in it, for which conditions can be created that connect the actual or potential presence of Covid 19 to the possibility of contracting the infection. This assessment must be carried out individually by each person who will have access to the event by estimating the risk index associated with their personal health status.

STEP 2 Risk management:

All interventions and procedures aimed at permanently removing or constantly containing the critical issues identified in the risk assessment phase.

PHASE 3 Risk communication:

All actions aimed at informing, training and sensitizing those affected by the potential risk

Risk assessment

The risk index will therefore be specific to each person.

As for Coronavirus, the data available so far allow us to say that this infection can cause different types of infection with which we can associate an IR.

Risk management

Viruses can enter and multiply in all people who come into contact with them, however causing different effects.

Potentially, they can all be at critical risk (3), because everyone could be "temporarily" in a "temporary" risk condition due to some imbalance and weakening of the immune system.

The G factor is therefore individual and depends on various factors.

- **Procedures for contrasting SARS-CoV-2 infection**
- **N. 1 - Correct behavior of the riders inside the place of the event.**
- Attendees must strictly comply with the indications given by the C.O. which are considered accepted from the time of registration to be made on www.enduranceonline.it.
- Correct information and awareness about correct behavior is considered the first and most important means of risk management.
- The president will have to provide for appropriate signs, encouraging the dissemination of messages to facilitate the management of flows and awareness of behavior.
- The manager in order to inform and train the athletes and their assistants, the Judging Commission and all the staff, makes information about correct behavior visible in the Secretariat area.
- (All1.). This information indicates

- Compliance with hand hygiene rules.
- The use of suitable personal protective equipment, starting with a mask that covers the nose and mouth.

The obligation to view this document in order to be properly informed about the procedures for contrasting SARS-CoV-2 infection.

- The obligation to evaluate your IR and act accordingly
 - Race n. 4 companions for each registered rider and the owner of the horse indicated in the passport but the same will not have access to the following areas: vet gate-cool area-rest area-as indicated in the FISE Protocol-Particular Rules Endurance point C.
 - Access restrictions to closed places and the obligation to sanitize surfaces.
- Any information the President deems useful for risk management.

1. Information on "How to wash your hands with soap and water"

2. Information on "How to wear a mask"

3. Signage "Obligation to keep the safety distance"

5. SARS-CoV-2 anti-contagion handbook

• **Procedure for limiting the risk of gathering inside the place of the event**

- *The president draws up the program of the event as planned as possible so as to dissuade any conditions of aggregations and to regulate the flows of the waiting spaces and in the various areas to encourage compliance with the social distance ,this last aspect pertains to individual responsibility.*
- *In order to avoid gatherings, the following protocols are put in place.*
- *Respect for the safety distance between people not belonging to the same household without device is required by the president (mask)*
- *The maximum number of people is calculated based on the capacity of the plants. It is estimated not less than 7 square meters of floor area per person (the Equestrian Centre plant is 31,510 square meters.) Max 4,500 people*
- *On the basis of an accurate schedule, the president, having assessed the size of the sports facilities of IPPODROMO DEL CASALONE which widely allow the distancing between the athletes, coordinating with the person in charge of the Anti-contagion Protocol, will identify and signal specific routes of entry and exit from the competition field. as well as the cool areas and rest areas that will be named and identified by means of specific signs (bib number).*
 - *As regards the exit of the horses outside the training facilities, control is not the responsibility of the President but is allowed by current legislation while maintaining the spacing that is also done naturally in the specific discipline.*

Sanitization of environments - Procedure for sanitizing surfaces and environments

Due to the possible survival of the virus in the environment for a long time, the places and areas are subjected to sanitation according to the following procedure:

- *Complete cleaning with water and common detergents once a day.*
- *Sanitization with 1% sodium hypochlorite after cleaning once a day. For surfaces that they can be damaged by sodium hypochlorite, 70% ethanol is used after cleaning with a neutral detergent.*

Ventilation of closed rooms

During cleaning with chemicals, ventilation of the rooms is ensured. All cleaning operations are carried out using PPE

All frequently touched surfaces must be cleaned with particular care, such as walls, doors and windows surfaces, toilet and sanitary surfaces.

- ***Personal hygiene***

- *Hand hygiene. The correct application of preventive measures, such as hand hygiene, can reduce the risk of infection.*
- *The president provides special alcoholic gel dispensers with an alcohol concentration of 60-85%,*
- *Preventive measures such as hand hygiene, respiratory hygiene and social distancing, are advertised inside the place of the event through special information materials displayed.*

Emergency procedure in case of entry into the center of a positive or positive potential for SARS-CoV-2 infection

- ***If the President becomes aware that a positive for SARS-CoV-2 infection has had access to the place of the event, he carries out the following procedure:***
- *Contact the competent authority immediately, if not already informed of the fact, making available all the information in its possession.*
- *Tuscany toll-free number: 800 55 60 60*
- *Consult the register of entrances in order to determine the date of entry of the positive and the people who came into contact with it.*
- **Provides for the sanitization, as per current legislation, of all environments.**

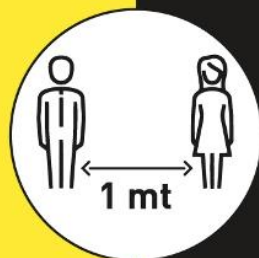

CREW POINT

It is strictly forbidden to access the assistance areas to unauthorized persons, under penalty of disqualification of the rider in the race, except as provided in point C, particular Endurance rules of the FISE protocol.

Base camp

The organizing committee appoints a person responsible for managing access.

Paddock area

If there is a paddock area, the same must be delimited and the access allowed for a maximum of 4 people per horse, which will be indicated by the competitor among those accredited.

Visits area

The preliminary visits / veterinary gate area must be organized with a sufficiently large "heart" area to guarantee the maintenance of an adequate distance between binomial and binomial.

Access to this area is allowed to one person per horse. The entrance and exit must be separated. Mask must be worn.

Cool Area -

The assistance area must be delimited and sufficiently large to guarantee the maintenance of an adequate distance between binomial and binomial and between tub and tub. In addition to the competitor, access is allowed 4 assistants per horse, in addition to the technician or accompanying person with delegation from the responsible technician in the event of a minor, who must be identified with the same bib number as the competitor to be assisted and must wear the masks as well as remaining the time strictly necessary to carry out the assistance.

**Valutazione del rischio biologico correlato all'improvvisa

1. Scopo

*Premesso che, in relazione alle situazioni di pericolo venutesi a creare nel nostro Paese con la diffusione del COVID-19, in riferimento alle specifiche disposizioni legislative, ed in particolare al DPCM 22 marzo 2020, l'attività di Endurance Equestre è classificata con rischio basso, il presente documento è stato redatto al fine di valutare il rischio biologico correlato all'improvvisa emergenza legata alla diffusione del virus SARS-CoV-2 per **Generali endurance A.S.D.** al fine di definire un insieme di misure preventive e protettive atte a ridurre al minimo tale rischio per **l'evento che si terrà a Grosseto nei giorni 26-27 Agosto 2022.***

Ciò premesso, l' ASD si è attivata per adottare tutte le misure necessarie a garantire il contrasto ed il contenimento della diffusione del nuovo virus nel corso dell'evento denominato "AREZZO RIDE", disciplinandolo con il presente piano per rendere l'evento un "luogo sicuro" in cui i cavalieri, la Commissione giudicante, lo Staff, compatibilmente con le limitazioni poste dagli specifici provvedimenti normativi possano praticare la disciplina equestre dell'Endurance.

A tale riguardo, vengono forniti tutti gli accorgimenti necessari che devono essere adottati per contrastare la diffusione ed il contagio del COVID-19.

Quanto contenuto nel presente documento dovrà essere portato a conoscenza e recepito da chiunque sarà autorizzato all'ingresso nell'evento sopra indicato

.2. Introduzione

2.1. Aspetti generici ,

L'Organizzazione mondiale della sanità (Oms) ha annunciato in data 11.02.2020 il nuovo nome per la malattia da nuovo coronavirus: Covid-19. Il nome è l'acronimo di Co (corona); Vi (virus); D ('disease', malattia) e 19 (l'anno di identificazione del virus).

I "Coronavirus" sono una vasta famiglia di virus noti per causare malattie che vanno dal comune raffreddore a malattie più gravi come la Sindrome respiratoria mediorientale (MERS) e la Sindrome respiratoria acuta grave (SARS). Il virus che causa l'attuale epidemia di coronavirus è stato denominato "SINDROME RESPIRATORIA ACUTA GRAVE CORONAVIRUS 2" (SARS-CoV-2). Si tratta di un nuovo ceppo di coronavirus che non è stato precedentemente mai identificato nell'uomo prima di essere segnalato a Wuhan (Cina) a dicembre 2019.

La malattia provocata dal nuovo Coronavirus ha un nome: "COVID-19" (dove "CO" sta per corona, "VI" per virus, "D" per disease e "19" indica l'anno in cui si è manifestata).

La malattia presenta un "periodo di incubazione" ovvero il periodo di tempo che intercorre fra il contagio e lo sviluppo dei sintomi clinici. Si stima attualmente che vari fra 2 e 11 giorni, fino ad un massimo di 14 giorni.

I sintomi più comuni di una persona affetta da COVID-19 sono febbre, stanchezza e tosse secca. Alcuni pazienti possono presentare indolenzimento e dolori muscolari, congestione nasale, naso che cola, mal di gola o diarrea. Questi sintomi sono generalmente lievi e iniziano gradualmente. Nei casi più gravi, l'infezione può causare polmonite, sindrome respiratoria acuta grave, insufficienza renale e persino la morte.

A questo proposito, alcune persone si infettano ma non sviluppano alcun sintomo. Generalmente i sintomi sono lievi, soprattutto nei bambini e nei giovani adulti, e a inizio lento. Circa 1 su 5 persone con COVID-19 si ammala gravemente e presenta difficoltà respiratorie, richiedendo il ricovero in ambiente ospedaliero.

2.2. Modalità di trasmissione

I Coronavirus possono essere trasmessi da persona a persona, di solito dopo un contatto stretto con un paziente infetto, ad esempio tra familiari o in ambiente sanitario.

Anche il nuovo Coronavirus responsabile della malattia respiratoria COVID-19 può essere trasmesso da persona a persona tramite un contatto stretto con un caso probabile o confermato.

Il nuovo Coronavirus è un virus respiratorio che si diffonde principalmente attraverso il contatto stretto con una persona malata. La via primaria sono le goccioline del respiro delle persone infette ad esempio tramite:

- *la saliva, tossendo e starnutendo*
- *contatti diretti personali*
- *le mani, ad esempio toccando con le mani contaminate (non ancora lavate) bocca, naso o occhi*
- *In casi rari il contagio può avvenire attraverso contaminazione fecale. Normalmente le malattie respiratorie non si tramettono con gli alimenti, che comunque devono essere manipolati rispettando le buone pratiche igieniche ed evitando il contatto fra alimenti crudi e cotti.*
- *Studi sono in corso per comprendere meglio le modalità di trasmissione .*

- **2.3. Prevenzione del contagio** *Nessun virus è capace di vivere e di riprodursi al di fuori di un essere vivente (uomo o animale), ma può sopravvivere un po' di tempo all'esterno (si ritiene che il Coronavirus non possa sopravvivere più di qualche ora fuori dell'ospite, ma i dati sono ancora incerti dato che il CoVID-19 è un virus nuovo e ancora non sufficientemente conosciuto e studiato). La vera prevenzione del contagio dipende dalla probabilità che le persone hanno di entrare in contatto con i virus emessi da soggetti malati o portatori sani (sono definiti portatori sani coloro che sono stati contaminati dal virus senza manifestare i sintomi o perché è ancora presto per manifestarli o perché non li manifesteranno ma i essendo capaci di eliminare il virus).*

6. Rischio Covid-19

Il controllo del rischio si divide in tre fasi

This Biosecurity plan is drawn up in accordance with the FEI Post EHV-1 Return to Competition Regulation set out on 9 April and extended from 1 January 2022 in order to allow the return to competitions and at the same time protect horses and equestrian sports from the consequences of infectious diseases transmitted before during and after FEI events. Assessment of the biological risk related to the sudden emergency linked to the spread of EHV-1

Given that Italy is one of the countries indicated by the FEI among those that need measures that allow the return to competitions in total safety in relation to the dangerous situations that have arisen in 2021 with the spread of the EHV-1 HERPES virus, this document was drawn up in order to define a set of preventive and protective measures aimed at minimizing the risk of contagion for the event to be held in Grosseto on 26-27 August 2022

That said, the ASD has taken steps to take all the necessary measures to ensure the contrast and containment of the spread of the new virus, regulating it with this plan to make the event a "safe place" for the participating horses.

In this regard, all the necessary precautions are provided that must be adopted to counter the spread and contagion of the EHV-1 virus.

The contents of this document must be brought to the attention and acknowledged by anyone authorized to enter the event indicated above.

2. Introduction

2.1. Generic aspects,

The EHV virus occurs in 4 different types that affect 4 different systems of the horse, in this case the most lethal and contagious is that of type 1, in jargon EHV-1.

2.2 Symptoms of EHV-1

The most common form is type 1 which affects the respiratory system of the horse. In the most common form, it presents respiratory diseases with variable symptoms that include fever, nasal discharge, swollen lymph nodes, cough, loss of appetite and significant physiological drops, which are quite common symptoms and can be misleading and alarming those who observe the horse. In more serious cases, the Herpes Virus can also have repercussions from a neurological point of view, leading to paralysis and death.

2.2. Method of transmission

The EHV-1 virus, also known as Rhinopneumonia, has a very high viral load and is very easily transmitted by air, by direct contact between horses and also through surfaces that have come into contact with the viral components. For this reason, both sporting events and daily life in individual stables can be dangerous if the necessary precautions are not taken. It is possible, however, that horses spread the Equine Herpes Virus even without showing clinical signs (the so-called asymptomatic carriers), transmitting it only in certain environmental conditions such as stress, transport and competitions.

2.3 Diagnosis

Observing symptoms, especially at the respiratory level, cannot always lead to a correct diagnosis of rhinopneumonia, so in these cases it is categorically recommended to contact a veterinarian who can evaluate all the hypotheses. Using a classic swab or serological tests, it is possible to establish whether a respiratory infection is associated with EHV-1, by taking two blood samples 10 days apart on which the antibody titration is carried out.

2.4 Treatment and convalescence

The recommended treatment starts, first of all, with the isolation and quarantine of the person infected with the herpes virus. Unfortunately, being a virus, there is no specific and targeted cure. Treatment of equine herpes virus respiratory infections usually consists of supportive therapy, as human anti-herpes drugs are not effective in horses. Antipyretics and antitussives are administered, but also antibiotics to prevent or fight secondary bacterial infections, and to shorten the recovery period. However, with the help of a veterinary expert, a cure can be identified to treat the symptoms resulting from EHV-1 such as general weakness, loss of appetite and apathy. It is possible to preserve his respiratory health in a preventive manner through alternative methods recommended by us such as purified hay. However, in summary, the only remedies are prevention and the vaccine.

2.5 Prevention

- *In order to reduce the incidence of EHV-1 infection and to minimize its spread, it is necessary to sanitize the living environments of horses combined with particularly thorough hygiene through disinfectants.*
- *The isolation of the horse and tools is mandatory in case of contact with the virus.*
- *The prevention of contagion depends on the probability that horses have of coming into contact with the virus emitted by a sick person or a healthy carrier (a healthy carrier is defined as the person who, even if contaminated, does not show symptoms or because it is too early to manifest them or because will never manifest being able to eliminate the virus autonomously).*

5. Definition of liability

• In compliance with the provisions of the FEI, the Ministry of Health, the General Directorate of Animal Health and the FISE, the President identifies a method of control and management of the risk inherent in the event and informs the participants about the procedures for managing the risk inherent in the contagion and transmission of the EHV-1 virus

The participants in the competition, their assistants, the Staff, the Officials correctly informed by the President have the responsibility of respecting the behaviors defined by the regulations in force and by the rules laid down by the ASD with this document.

6. Risk HEV-1

Risk control is divided into three phases

RISK ASSESSMENT

Identification of the specificity of the structure and of the plants exercised in it, for which conditions can be created that link the actual or potential presence of the EHV-1 virus to the possibility of contracting the infection. This evaluation is carried out individually on each horse that will participate in the event

All the procedures aimed at permanently removing or constantly containing the criticalities identified in the risk assessment phase.

RISK COMMUNICATION

All actions aimed at informing, training and raising awareness of the subjects concerned by the potential risk

Procedures for contrasting EHV-1 infection

No. 1 - Correct behavior of the riders within the place of the event.

Visitors must strictly comply with the instructions given by the O.C. which are considered accepted from the moment of registration to be made on www.enduranceonline.it.

- Correct information and awareness of correct behavior is considered the first and most important means of managing risk.
- The President will have to provide suitable signs, encouraging the dissemination of messages and raising awareness of behavior.
- In order to inform and train the athletes and their assistants, the Judging Commission and all the staff, the person in charge makes information on the correct behavior to prevent the spread of the EHV-1 virus visible in the Secretariat area
- *The obligation to wash your hands with gel at the entrance and exit of the stables*
- *The obligation not to water horses on common containers but to use only their own containers*
- *The obligation to view this document in order to be properly informed about the procedures for fighting the infection*
- *The obligation to record the horse's temperature at least in the 3 days prior to the event in the FEI HORSE APP*
- *The obligation to measure and record the temperature twice a day in the FEI HORSE APP*
- *The obligation to observe the entry and exit from the stables as indicated by the O.C.*
- *The obligation to carefully observe the distance from other horses of at least 5 m.*
- *The obligation to saddle the horse inside the assigned box and to use only personal harness*
- *The obligation to send the box form by 22 Augustu with the indication of the date and time of arrival*

Any information the President deems useful for risk management.

Personal hygiene

Hand hygiene. The correct application of preventive measures, such as hand hygiene, can reduce the risk of infection.

The president provides special dispensers of alcoholic gels with an alcohol concentration of 60-85%,

Emergency procedure in case of entry into the center of a horse suspected of EHV-1

If a horse exhibits the symptoms of the HEV-1 virus, the VSM will immediately arrange the movement to the isolation area prepared in advance by the O.C. as per FEI provisions and will proceed with the provisions of the Veterinary Regulations.

The C.O. will arrange for the immediate disinfection of the box used.

Verification and review of the document consist in the evaluation of all the activities provided for in this document and implemented for the prevention and control of the HEV-1 risk, in order to evaluate their effectiveness. Therefore, the President will adapt this document to any regulatory changes that will occur from today's date to the date of carrying out the sporting event.

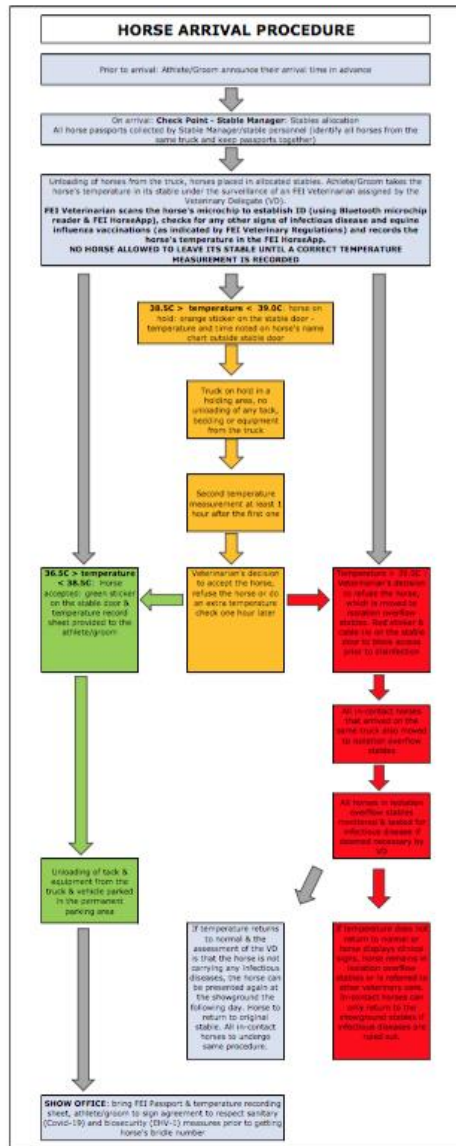

1. Scopo

*Premesso che l'Italia rientra fra i paesi indicati dalla FEI fra quelli che necessitano di misure che permettano il ritorno alle competizioni in totale sicurezza in relazione alle situazioni di pericolo venutesi a creare nelle scorse settimane con la diffusione del virus EHV-1 HERPES VIRUS EQUINO, il presente documento è stato redatto al fine di definire un insieme di misure preventive e protettive atte a ridurre al minimo il rischio di contagio per **l'evento che si terrà a Grosseto nei giorni 26-27 Agosto 2022***

Ciò premesso, l'ASD si è attivata per adottare tutte le misure necessarie a garantire il contrasto ed il contenimento della diffusione del nuovo virus disciplinandolo con il presente piano per rendere l'evento un "luogo sicuro" per i cavalli partecipanti .

A tale riguardo, vengono forniti tutti gli accorgimenti necessari che devono essere adottati per contrastare la diffusione ed il contagio del virus EHV-1

Quanto contenuto nel presente documento dovrà essere portato a conoscenza e recepito da chiunque sarà autorizzato all'ingresso nell'evento sopra indicato

2. Introduzione

2.1. Aspetti generici ,

Il virus EHV si presenta in 4 tipi diversi che colpiscono 4 diversi apparati del cavallo, nella fattispecie il più letale e contagioso è quello di tipo 1, in gergo EHV-1.

2.2 Sintomi dell'EHV-1

La forma più diffusa è quella di tipo 1 che colpisce l'apparato respiratorio del cavallo. Nella forma più comune presenta patologie respiratorie con sintomi variabili che comprendono febbre, scolo nasale, ingrossamento dei linfonodi, tosse, inappetenza e notevoli cali fisiologici, che sono sintomi abbastanza comuni e possono trarre in inganno e allarmare chi osserva il cavallo. In casi più gravi, l'Herpes Virus può avere ripercussioni anche dal punto di vista neurologico, portando a paralisi e a morte.

2.2. Modalità di trasmissione

Il virus EHV-1, conosciuto anche come Rinopolmonite, ha una carica virale altissima e si trasmette molto facilmente per via aerea, per contatto diretto tra cavalli e anche attraverso superfici venute a contatto con i componenti virali. Per questo motivo, sia le manifestazioni sportive che la vita quotidiana nelle singole scuderie possono risultare pericolose se non si prendono le dovute precauzioni. E' possibile, tuttavia, che i cavalli diffondano l'Herpes Virus equino anche senza mostrare segni clinici (i cosiddetti portatori asintomatici), trasmettendolo solo in determinate condizioni ambientali come stress, trasporto e competizioni.

2.3 Diagnosi

L'osservazione dei sintomi, specialmente a livello respiratorio, non sempre può condurre ad una corretta diagnosi della Rinopolmonite, per cui in questi casi è consigliato categoricamente di contattare un veterinario che possa vagliare tutte le ipotesi. Tramite un classico tampone o attraverso esami sierologici è possibile stabilire se un'infezione respiratoria è associata a EHV-1, prelevando due campioni di sangue a distanza di 10 giorni sui quali viene effettuata la titolazione anticorpale.

2.4 Cure e Convalescenza

Il trattamento consigliato parte, innanzitutto, dall'isolamento e la quarantena del soggetto contagiato dall'herpes virus. Purtroppo, essendo un virus, non esiste una cura specifica e mirata. Il trattamento delle infezioni respiratorie da Herpes Virus Equino è solitamente costituito da terapia di sostegno, poiché i farmaci anti-Herpes ad uso umano non sono efficaci nel cavallo. Vengono somministrati antipiretici ed antitussigeni, ma anche antibiotici per prevenire o combattere infezioni batteriche secondarie, e per ridurre il periodo di convalescenza. Tuttavia, con l'aiuto di un esperto veterinario, si può individuare una cura per trattare i sintomi sorti di conseguenza all'EHV-1 come indebolimento generale, inappetenza e l'apatia. E' possibile preservare la sua salute respiratoria in maniera preventiva attraverso metodi alternativi da noi consigliati come il fieno purificato. Tuttavia, ricapitolando, le uniche cure risolutive sono la prevenzione ed il vaccino.

2.5 Prevenzione

Al fine di ridurre l'incidenza dell'infezione da EHV-1 e per minimizzarne la diffusione è necessaria la sanificazione degli ambienti di vita dei cavalli abbinata ad un'igiene particolarmente profonda attraverso prodotti disinfettanti.

E' obbligatorio l'isolamento del cavallo e degli strumenti in caso di contatto con il virus.

La prevenzione del contagio dipende dalla probabilità che i cavalli hanno di entrare in contatto con il virus emesso da un soggetto malati o portatore sano (si definisce portatore sano il soggetto che pur se contaminato non manifesta sintomi o perché troppo presto per manifestarli o perché non li manifesterà mai essendo capace di eliminare il virus autonomamente).

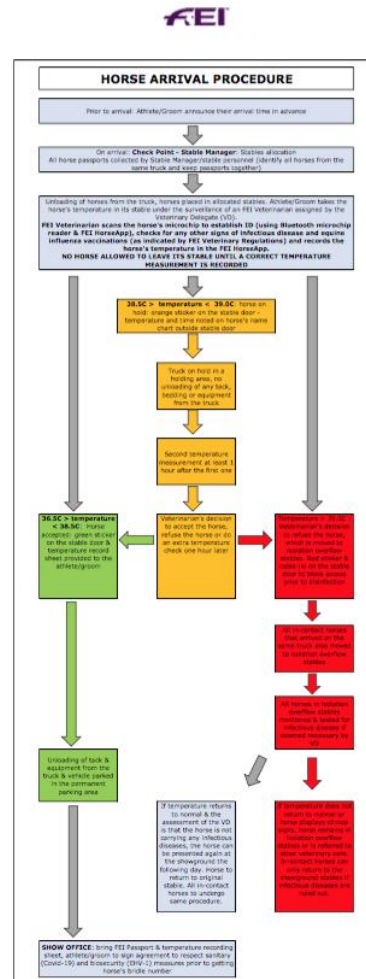

IV. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

FEI Veterinary Regulations, Chapter VIII: Horses participating in FEI Events are subject to injury surveillance protocols; and in the event of fatality, a post-mortem examination.

6. TRANSPORT OF HORSES

Horses must be fit to travel and be transported in suitable vehicles. Any government requirements for disease testing and control must be requested well in advance, to ensure that the horse is in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have the responsibility to comply with national legislation in both their country of origin and the host nation of the Event. Where necessary athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005 concerning the protection of animals during transport within the Member States of the EU.

7. VENUE ARRIVAL INFORMATION & FITNESS TO COMPETE

7.1 PASSPORTS. FEI General Regulations, Art. 137

For all issues relating to FEI Horse Passports/FEI Recognition Cards please contact your National Federation.

All Horses competing at FEI Events must be registered with the FEI.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

NB: Horses entered in CIMs in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (FEI General Regulations, Art. 137.2).

Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be **subject to Sanctions in accordance with Annex VI of the FEI Veterinary Regulations** and may not be allowed to compete.

NB for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

7.2 VACCINATIONS - EQUINE INFLUENZA. FEI Veterinary Regulations, Art. 1003

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

VACCINATION	PROTOCOL	ELIGIBILITY TO ENTER VENUE
Primary Course	1 st Vaccination: day 0 2 nd Vaccination: day 21-92	May compete 7 days after the 2 nd Vaccination
First Booster	Within 7 months of the 2 nd vaccination of the Primary Course	May compete for 6 months +21 days after the 2 nd vaccination of the Primary Course Must not compete in the 7 days after receiving a vaccination
Boosters	MINIMUM: within one year of previous booster vaccination IF COMPETING: must be in the 6 months +21 days of the booster previous vaccination	Must have been vaccinated within 6 months +21 days before arriving at the Event Must not compete in the 7 days after receiving a vaccination

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these Veterinary Regulations. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the relevant territory.

7.3 EXAMINATION ON ARRIVAL. FEI Veterinary Regulations, Art. 1031

On arrival at an Event venue, all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue. PRs must fulfil the Horse Health Requirements via the FEI HorseApp in advance of the event which will be checked at the Examination on Arrival.

7.4 HORSE INSPECTIONS. FEI Veterinary Regulations, Art. 1034-1042

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

7.5 LIMB SENSITIVITY EXAMINATION. FEI Veterinary Regulations, Art. 1048-1053 and Annex VIII

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event. For Jumping that includes, but is not limited to, between rounds and before the Jump Off. For Endurance that includes, but is not limited to, pre-ride, during the ride and after the ride. Horses may be examined once or on multiple occasions during the Period of an Event. Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

8. EQUINE ANTI-DOPING AND CONTROLLED MEDICATION PROGRAMME (EADCMP). FEI Regulations, Chapter VII**8.1 SAMPLING. FEI Veterinary Regulations, Chapter VII**

All horses competing at FEI Events may be subject to sampling for the presence of Prohibited Substances in accordance with the Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

8.2 ELECTIVE TESTING. FEI Veterinary Regulations, Art. 1058

Elective Testing may be carried out prior to an Event to check for the presence of Prohibited Substances. Please refer to <https://inside.fei.org/fei/cleansport/horses> for information and details.

XIV. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEIs' Anti-doping Rules for Human Athletes (ADRHA).

XV. ADDITIONAL INFORMATION

1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic (“Policy”) <https://inside.fei.org/fei/covid-19/return-to-play/policy-tools> is mandatory and applies for any FEI Event taking place **as of 1 July 2020**. The Policy has been developed based on currently accepted best practices by the WHO and US Center for Disease Control (CDC) and will be continually reviewed and updated as more information becomes available. It is not intended to replace the applicable guidance and policies from domestic government and health authorities, but to supplement their recommendations with sport specific considerations.

The OC shall submit the risk mitigation plan (including name and contact details of the person in charge) to the FEI as an annex to the Event Schedule, **at the latest ten (10) working days before the event’s deadline for Definite Entries**.

Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy **will be removed from the FEI calendar** in accordance with Article 112.3 of the FEI General Regulations.

ASSUMPTION OF RISK / WAIVER OF LIABILITY

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,
3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
4. The Participants, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (“RELEASEES”), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.

2. Insurances And National Requirements

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate.

2.1 ATHLETES, OWNERS AND SUPPORT PERSONNEL

2.1.1 Personal Accident and Health Insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending at/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

2.1.2 Personal Property Insurance

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

2.1.3 Press Equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

2.2 ATHLETES AND OWNERS

2.2.1 Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

2.2.2 Additional Liability Information

2.2.3 Horse Insurance

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

[FEI Permitted Treating Veterinarians \(PTVs\) \(Art 1005\) are to have adequate professional indemnity insurance.](#)

3. Protests / Appeals

To be valid, all Protests and Appeals must be made in writing and accompanied by a deposit of CHF150. – or equivalent.

4. Disputes

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

5. Modifications Of Schedule

In exceptional circumstances, together with the approval of Chefs d'Equipe and Ground Jury the OC reserves the right to modify the schedule in order to clarify any matter or matters arising from an omission or due to unforeseen circumstances.

Unforeseen circumstances do not include situations arising as a result of the OC altering the approved Schedule without FEI's authorisation. Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the FEI Secretary General by the Foreign Judge.

6. Additional Information from the OC

The event will respect the covid - 19 health protocol provided by the Ministry of Health and the NF for the contrast and containment of the virus covid 19. Our O.C.drew up the anti-contagion protocol attached here.

7. Prize Money Distribution:

DEDUCTIONS FROM PRIZE MONEY AT COMPETITIONS

Full details of any deductions from prize money should be outlined in the schedule. This includes government taxes. If it is necessary for organisers to deduct such taxes, they should provide participants with an official form indicating the amount of tax deducted upon application.

The tax form should be provided to the athletes upon arrival and returned to the organiser prior to departing.

7.1 Total Prize Money NO PRIZE MONEY

IMPORTANT

The value of the 1st prize must not exceed 1/3 of the total prize money distributed for the competition. The minimum number of prizes offered for each competition must be allocated on the basis of one prize for every commenced four Athletes, with a minimum of five prizes. The total amount of prize money shown for each Competition in the schedule must be distributed. (Art 127, 128)

7.2 Awards

An award must be given to all competitors who complete the ride. Please describe awards to be distributed.

Please note that as per Art. 109.6 (GR): ORGANISERS of International Events must inform the FEI and NFs whose teams or individuals have taken part, of the results and prize money paid to each placed Athlete and team, within five (5) days following the Event, unless otherwise specified for qualification and ranking reasons as communicated by the FEI.

Failure from ORGANISERS of International Events to provide the FEI with the appropriate result(s) and/or prize money information by the aforesaid deadline and/or in the aforesaid format shall entail a warning for the first violation and thereafter a fine of CHF 1'000.- per violation.

The FEI may request a copy of the official PDF result signed by the relevant Officials at the Event.

FEI Endurance Organisers' Protocol

With an aim to further ensure the welfare of equine and human athletes at International Endurance Events, the safety of all participants and the implementation and respect of common principles of behaviour, fairness, and sportsmanship, the FEI has created this FEI Endurance Organiser's Protocol (hereinafter the "Endurance Protocol") to guarantee the correct and full application of the applicable FEI Rules and Regulations in your Events, in particular but not limited to, the FEI General Regulations, the FEI Endurance Rules, the FEI Veterinary Regulations, the FEI Anti-Doping Rules for Human Athletes and the FEI Equine Anti-Doping and Controlled Medication Regulations.

In order for the FEI to approve the competition schedules the Endurance Protocol **must** be signed by the Organiser and the National Federation, listing the Event(s). By signing the Endurance Protocol both aforementioned parties agree to comply with all applicable FEI Rules and Regulations, and in particular (but not limited to), with the following requirements:

1. Full cooperation must be given to the FEI Officials to ensure that they can perform their tasks according to the FEI Endurance Rules, in particular:
 - Ground Jury – Art. 853
 - Technical Delegate – Art. 852
 - Veterinary Commission – Art. 854
 - Chief Steward – Art. 855
 2. Full cooperation must be given to the FEI Independent Governance Advisors (IGAs) to ensure that they can perform their tasks according to the FEI Endurance Rules Art. 856
 3. The welfare of the horse must be a first priority and you must allow the FEI Officials to take all necessary measures to safeguard it, as per the FEI Endurance Rules, including but not limited to:
 - Loops of the course must not be specially designed and/or constructed to encourage high speeds - Art. 818
 - Allowing for the reduction of the pulse criteria - Art. 816.9.2. The pulse criteria may be reduced during the ride if, in the opinion of the President of the Veterinary Commission in consultation with the Foreign Veterinary Delegate, the President of the Ground Jury and the Technical Delegate they believe there is a danger to the safety of the Horses.
 - The Veterinary Commission has absolute control on all matters concerning horse welfare – Annex 5, Art.1.
 - The Technical Delegate or the Ground Jury together with the Veterinary Commission can decide to modify the length of timed holds according to extreme weather conditions or other exceptional circumstances.... - Art. 816.9.3.
- 3.1 If the Event combines a CEN(s) with a CEI(s), the Organiser will take all reasonable measures to ensure the biosecurity of the FEI Horses is safeguarded including but not limited to:
- Ensure that FEI horses participating in the CEI are stabled separately from CEN horses participating in the CEN ride. If no stabling is required at your Event, please make sure they are separated in the cooling and holding areas.
 - The use of common water troughs for Horses is prohibited. Water must be drawn with a clean bucket. Horses must not drink directly from the trough.

- Ensure that the examination upon arrival is done for all Horses according to article 1031 of the Veterinary Rules.
- It is advised that the temperature of CEN Horses is manually recorded 3 days prior to the event, and that this information is passed to the FEI Veterinarian that is carrying the Examination upon arrival.
- Ensure that all participants are advised to report any health issues to the FEI Veterinarian, so that Horse can be isolated and further testing can be done.
- Ensure that the veterinarians have enough sanitizers and gloves for the Horse inspections throughout the day.

**Please refer to the CEI_CEN Biosecurity Measures Leaflet for more information.*

4. The safety of the athletes, FEI Officials and public must be safeguarded at all times and FEI Officials must be allowed to take all necessary measures to ensure safety, as per the FEI Endurance Rules/FEI GRs:
 - The field of play - Art. 813
 - Number of crew members allowed - Art. 813.2.2
 - Horses must remain capable of being clearly observed at all times - Art. 813.5
 - Permitted Assistance during Event or on Course - Art. 822.4
 - Prohibited Assistance - Art. 822.5
 - Postponement and/or cancellation of an Event - FEI GRs 109.12
5. The FEI Officials' Code of Conduct must be adhered to including the obligations and restrictions pertaining to the "Endurance Official's Per Diems".

Any breach of the FEI Rules and Regulations will be prosecuted according to the FEI Legal System (Chapter VIII of the FEI General Regulations). Failure by an Organiser to comply with the terms of this Protocol may also lead to sanctions including the removal of future events from the FEI Calendar in accordance with Article 112.3 of the FEI General Regulations.
